

WHAT IS COVERED

- This policy covers you for unforeseen, unexpected mechanical or electrical failure / damage to the covered components as defined, while the policy is still active.
- The indemnity to the insured is based on the cost of physically removing the affected insured part from the vehicle, repairing it (or replacing it with a part equal to but not superior to when new), and then replacing it in the vehicle.
- Our liability is limited to the lower amount of either the applicable benefit limit or the actual cost of repairs.

WAITING PERIOD AND EXCESS

- There is no waiting period if you move your cover from the original manufacturer warranty over to us without a break in cover.
- If there is a break in cover, there will be a waiting period from the date of inception of the policy during
 which you cannot make any claims. If you have any problems with your vehicle during this period, you will
 be responsible for the repairs and costs.
 - o You must make 3 (three) payments to us before you can submit any claims.
- If you upgrade your plan type (for example you change from a Silver Plan to a Gold Plan), there is a waiting
 period before the new, higher benefits apply.
 - You must make two monthly payments towards the upgraded plan before your new benefits will take effect.
- o You will however only be able to claim the lower benefit amounts during this waiting period.
- If you downgrade your plan (for example from a Gold Plan to a Silver Plan) the new benefit limits will apply
 from the first payment of the lower premium.
- If there is a break in your cover because you did not make payment of your monthly premium, there is a 15
 (fifteen) day waiting period from the date we receive the money until your policy becomes active again
 and you can submit claims
 - o Any claims occurring during this period are for your own expense.
- There are no excesses payable under this policy.

EXCLUSIONS

- Any claim for any component not listed as a covered component.
- · Any claim for a covered component that has failed due to or as a result of a non-covered component failing.
- Any claim for any routine or scheduled servicing of the vehicle.
- · Any claim for oil consumption problems where overheating related claims have been honoured within the proceeding 6 (six) months.
- · Any claim for oil leaks or any damage caused by or as a result of oil leaks of any nature.
- Any claim for any damage that occurred before the inception date of this policy.
- Any claim for any loss or damage normally recoverable under any other insurance policy, notwithstanding that no such insurance has been arranged, or that the costs and
 expenses are not payable thereunder because of the existence of a deductible excess or first amount payable, or for any other reason whatsoever.
- Any claim for loss or damage that occurs while the vehicle's odometer is not connected or in working order, or where the current odometer reading of the vehicle cannot be reliably obtained.
- Any claim for loss or damage of any component that is covered under the manufacturer's warranty.
- Any claim for loss or damage to the vehicle or parts of the vehicle which are recalled or are to be recalled by the vehicle manufacturer.
- Any claim for loss or damage caused by or arising from:
 - o Improper or inadequate servicing and maintenance of the vehicle.
 - o Improper repairs to the vehicle.
 - o Any use of experimental parts.
 - o Modifications which have not been approved by the vehicle manufacturer.
 - o The use of oils, fuels, or petroleum products in the vehicle's fuel or lubrication system for which the vehicle's engine and or ancillary systems were not designed, and or the use of contaminated oils, fuels, or petroleum products.
 - o Accident or water damage.
 - o Rodents or other animals.
- The past or present use of the vehicle:
 - o For racing.
 - o Speed testing.
 - o Or any other usage of a competitive nature.
 - o On roadways not usual to normal thoroughfares.
 - o Outside of the manufacturer's design intention.
- Driver abuse and or negligence, including but not limited to:
 - o Incorrect loading or towing of the vehicle.
 - o Incorrect jump starting of the vehicle.
 - o Any claim where prior written approval was not obtained from the claims department.
 - o Any claim for loss or damage not reported within 10 (ten) days of the incident occurring.
 - o Any claim for loss or damage which occurred after the expiry date of the policy.
 - o Any claim for loss or damage which occurred outside of the borders of South Africa.
 - o Any claim for loss or damaged covered under standard SAIA war, nuclear, riot, and strike exclusions.
 - o Any claim for loss or damage where the vehicles manufacturer warranty was cancelled by the manufacturer for any reason whatsoever.
